This agreement is made on the date as per overleaf "Exhibitor Contract" between the person/s or company hereafter called "the Exhibitor" and the Aesthetics Practitioners Advisory Network Pty Ltd ("APAN") hereafter called the "Organiser".

The Organiser agrees to promote and conduct the exhibition "**AUSTRALIAN AESTHETICS CONFERENCES 2017 – Adelaide**" **The Playford Adelaide MGallery by Sofitel** – 120 North Terrace, Adelaide SA. and the Exhibitor wants to participate in the said exhibition.

1. The physical area defined as the Exhibitor's stand will be the total area the Exhibitor will occupy, including any display items and the provided Trestle Table.
2. The Exhibitor shall not in any way obstruct the free movement of the delegates in walkways, entrances, service corridors or fire exits and shall not hinder the clear view of any other exhibitor's stand front. If in the opinion of the Organisers such an obstruction or hindrance exists, the Organisers shall ask the Exhibitor to remove the obstruction immediately.
3. The Organisers will provide appropriate Public Risk Liability insurance for the exhibition and stand areas.
4. The Organisers accept no liability for damage to Exhibits by any cause whatsoever. Insurance of the goods is the responsibility of the Exhibitor and this insurance should cover the ingoing and outgoing periods as well as the operational days of the Exhibition.
5. All electrical work undertaken must be at the consent of the Organisers and the The Playford Adelaide MGallery by Sofitel.
6. If the exhibitor wishes to make use of a microphone or any sound amplification they will need the prior approval of the Organisers.
7. In the unforeseen event or circumstance, which did render it necessary for the Organiser to alter the location of the stand space allocated to the Exhibitor, the Exhibitor accepts any re-allocation of space. The Organisers agree to, where possible, offer the second choice or similar.
8. If in the unforeseen event of postponement or amendment to the date for holding the event, "**AUSTRALIAN AESTHETICS CONFERENCES 2017 – Adelaide**" **The Playford Adelaide MGallery by Sofitel** – 120 North Terrace, Adelaide SA., the Organisers will not be liable for any loss occasioned.
9. The Exhibitor is responsible to see that all statutes, ordinances or regulations are respected in all circumstances
